About the Program:

Receiving an unexpected subpoena is one of the more unpleasant and daunting experiences encountered by practicing psychologists offering non-forensic therapy and assessment services. With minimal guidance and training provided by most graduate programs regarding how to navigate this process, and important jurisdictional differences in the law, clinicians are often left to fend for themselves without the requisite knowledge of what constitutes a valid subpoena and how best to proceed when served one. Too often, psychologists blindly comply with subpoenas that are invalid, or without adequately engaging relevant parties in an effort to minimize harm to their clients, themselves, and their profession. This can put a psychologist's licensure and livelihood at risk from complaints to the Board of Psychology or malpractice claims. This program will cover relevant Minnesota statutes, ethical guidelines, and helpful resources to consult before responding to a subpoena. It will provide practical tips and a suggested framework to help clinicians navigate potential legal and ethical quandaries that may arise in their practice should they receive unwanted subpoenas or court orders.
