



Background and Purpose

- The way that money is spent is based on MPA's strategic plan and its values - the financial categories used to describe this process should reflect the purpose of the organization



2021 Budget

- Very conservative budget based on 2020 financials and many unknowns due to the pandemic.
- Budgeted for increased E & T revenue as we have seen an uptick with our Friday Forums etc. being virtual and from adding items to our CE21 catalog.
- Did our best to budget for a virtual Annual Conference in 2021. Feel slightly short on our registration revenue goal but did bring in a lot more revenue than we did in 2020.
- Have had some success in our membership marketing efforts and anticipate higher membership dues revenue despite challenges that come with the pandemic
- MPA is aggressively managing costs
 - Working to engage volunteers more to reduce management fees
 - Reviewing income and expenses on a regular basis
 - Evaluating and eliminating lower value tasks/projects
 - Reviewing educational opportunities- both in person and online

Approximately \$26,000 in dues revenue (some of this spread out over 2 years)

Membership Task Force

- Continued the previous new membership promo with discounted opportunities to renew and managed to turn about 27% of the free promo members into a paying member
- Looking for new ways to add value and increase awareness
- Many divisions have found ways to increase engagement

Annual Conference Committee

- Planned a successful 2021 Virtual Conference
- Were able to increase exhibit, sponsor, and registration revenue over the 2020 virtual conference
- Required less staff time than the 2020 event and previous in-person events

Education & Training Committee –

- Offered 17 different educational opportunities, including a full day Trust session and full day Multicultural Summit
- Had almost 1,200 total registrations for our various educational events (not including conferences) throughout the year
- Review and approve CE for all MPA events and submit annual APA report
- Planned the full 2021 schedule for continuing education programs, all offerings virtual to adapt to the current environment. All efforts are being made to make sessions in-person beginning January 2022.
- Added 13 webinars to the online catalog (through August 2021)

Ethics Committee

- Grown the committee
- Continue to offer on-call ethics consultations to MPA members
- Presenting educational opportunities related to ethics
- preparing to improve/increase our division's internet presence

Payer Committee

- Formed connections with all payers to address issues as they arise
- Assisted with questions and the transition to telehealth due to the pandemic
- Still looking for a Chair of this committee

Diversity Committee

- Planned the February Friday Forum and reception honoring Dr. Beryl Wingate, Psy.D., LP
- Continued to offer virtual networking opportunities and Difficult Dialogue Sessions
- Conducted a Diversity, Inclusion and Belonging Survey
- Helped create several social justice stances on behalf of MPA

Rural Conference Committee

- Continuing to help MPA implement online educational opportunities with a focus in content for those in rural areas
- Continue to look for ways to improve resources and opportunities for rural psychologists in Minnesota
